## Vehicle Rental Agreement

This Contract is made and entered into on this 08/15/2024 by and between Chill Studio Production LLC ("Rental House"), a rental management company, and \_\_\_\_\_ ("Client"), the undersigned renter of the vehicle.

- 1. Purpose:** The Client acknowledges and agrees that the Rental House is renting a vehicle from U-Haul on behalf of the Client. The Client is the actual renter and shall bear all responsibilities as the lessee of the vehicle.
- 2. Responsibility for Damages:** The Client acknowledges that they are fully responsible for any damages to the vehicle during the rental period. The Rental House shall not be liable for any damages, including but not limited to, physical damage, theft, loss, or any other damage that occurs to the vehicle.
- 3. Responsibility for Vehicle Failure:** The Client acknowledges that the Rental House shall not be held responsible for any vehicle failure, mechanical breakdown, or any other issues related to the performance of the vehicle. The Client agrees to address any such issues directly with U-Haul or the appropriate service provider.
- 4. Payment of Fees:** The Rental House agrees to pay all rental fees. However, the Rental House will not be responsible for any costs incurred due to damages or vehicle failures.
- 5. Fuel and Mileage Responsibility:** The Client acknowledges that the fuel level of the vehicle must be refueled to the same level as it was at the time of rental. A limitation of 350 miles per rental period is placed on the vehicle. Any mileage exceeding 350 miles will be charged at a rate of \$0.79 per mile.
- 6. Indemnification:** The Client agrees to indemnify, defend, and hold harmless the Rental House from and against any and all claims, liabilities, damages, losses, or expenses arising from or related to the rental vehicle, including but not limited to legal fees and costs incurred in connection with the defense of any claims.
- 7. Governing Law:** This contract shall be governed by and construed in accordance with the laws of the State of [Your State], without regard to its conflict of law principles.

**8. Entire Agreement:** This contract constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, negotiations, and discussions, whether oral or written, between the parties.
